CEMETERY CHARGES w.e.f. 1st April 2010

Table of fees, payments and sums fixed and settled under Section 34 of the Burial Act 1852, by the Parish Council of Willington, acting as the Burial Authority for the Parish of Willington.

1. INTERMENTS

(Note . Willington Parish Council does not provide a grave digging service for burials)

a) In graves for which an exclusive right has been granted

i) a person whose age at the time of death exceeded one month but did not exceed 12 years	48.00	48.00
ii) a person whose age at the time of death exceeded 12 years	106.00	82.00

2. EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES

For the exclusive right of burial in perpetuity in an earthen grave

2 metres by 1 metre 69.00

3. HEADSTONES

a) Headstones not to exceed 762mm in height	68.00
b) Any inscription after the first on a headstone	41.00

4. GRAVESTONES, KERBSTONES & MONUMENTAL INSCRIPTIONS
(North side of Cemetery only)

For the right to erect and place:-

	£
a) A flat stone occupying a superficial area (not exceeding 2 metres by 1 metre)	45.00
b) A headstone not exceeding 762mm	68.00
c) Kerbstone or borderstones, with or without rails, chains or palisades, enclosing a space not exceeding 2 m by 1 m	68.00
d) Any inscription after the first on a grave stone or monument	41.00

All memorials in 3 & 4 above must be secured in accordance with the NAMM Code of Practice.

5. SCATTERING OR INTERMENT OF ASHES

(Note . Willington Parish Council does not provide a grave digging service for interment of ashes)

a) Scattering of ashes	42.00
b) Interment of cremated remains with exclusive right of burial 60cm by 60cm for 50 years	69.00
c) Subsequent interment of cremated remains	53.00
d) Tablet	45.00

6. CLERK'S FEE 55.00

7. ELIGIBILITY

The deceased should have lived in the Parish of Willington for the 12 months prior to his/her interment. Interments for non-parishioners are not allowed.

The foregoing fees (including the Clerk's fee), payments and sums will carry a 300% premium for interments in existing graves, where the person to be interred or in respect of whom the right is granted is, or was before death, not an inhabitant or parishioner of the Parish of Willington.

Reservation of plots for burials or interment of ashes is not permitted.

At a meeting of the Parish Council of Willington held on the 10th day of November 2009, the foregoing fees, payments and sums, payable under Section 34 of the Burial Act 1852, are hereby fixed and settled by the said Parish Council, to commence from 1st April 2010.
