532/19 Declarations of Members Interests

(a) Members must ensure that they complete the Declarations of Interest sheet prior to the start of the meeting in respect of items other than Disclosable Pecuniary Interests and must indicate the action to be taken (i.e. to stay in the meeting, to leave the meeting or to stay in the meeting to make representations and then leave the meeting prior to any consideration or determination of the item).

(b) Where a Member indicates that they have a Disclosable Pecuniary Interest but wish to make representations regarding the item before leaving the meeting, those representations must be made under item (c) of Public Speaking (if relevant).

(c) Members will be asked to confirm that the record is correct for Declarations of Interests for matters other than Disclosable Pecuniary Interests.

533/19 Public Speaking, including County, District and Police Representation

a) At the start of the meeting a period of not more than **fifteen minutes** will be made available for members of the public and members of the Council to comment on any matter already on the agenda. Each person may speak for up to **three minutes**. While members of the public are welcome to observe the full meeting, they **may not** take an active role once the question period has closed.

a) If the Police Liaison Officer, a County Council or District Council Member is in attendance they will be given the opportunity to raise any relevant matter. Members of the Council however will restrict Police matters they raise to those relating to their Council Ward.

b) Members declaring a prejudicial interest who wish to make representation or give evidence under the Code of Conduct relating to Agenda items shall do so at this stage.

534/19 To consider Planning Application Ref. No: DMPA/2019/1196. Outline application for 60 extra care flats and two bungalows along with ancillary shop, hairdressers, restaurant, parking provision and garages (appearance and landscaping reserved for later consideration) on LAND AT SK2829 0730 off Ivy Close, Willington, Derbyshire.

At a Meeting of Council on 12th November 2019, it was resolved to object to the above application. It was also agreed to request a consultation extension from the Local Planning Authority, and to engage a Planning Consultant to submit an objection to this proposal on behalf of Willington Parish Council.

The following can also now be confirmed;

- An extension to the consultation date has been agreed to 6th December 2019.
- Of the three Planning Consultants originally contacted, one hasn't responded, and the other two have declared interests and aren't able to carry out this work.
- A further Consultant has been contacted – a quotation will be provided at the Meeting.
- The Locum Clerk distributed further confidential information from the Planning Authority on 21st November 2019.

In light of this information, further instruction is sought.

Please note that if Councillors wish to discuss the information distributed on 21st November 2019, it will be necessary to move the item into private during this discussion, due to the commercially sensitive information.
